- 6 The Bid will be opened in the presence of Bidder's representatives who choose to attend at 2:00 PM on 2073/9/13 at the Dashrathchand Municipality Office, Baitadi. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validate period.
